

GUS JOHNSON SCHOLARSHIP PROGRAM

Thank you for your interest in the Gus Johnson Scholarship Program.

The eligibility requirements are as follows:

1. The applicant must not be receiving tuition reimbursement from their company.
2. The applicant must be employed in a community served by BOMA Hartford.
3. The applicant must be a resident of a community served by BOMA Hartford.
4. The applicant must have a minimum of one year of experience in commercial real estate.
5. The applicant is responsible for paying the one-time BOMI enrollment fee.

The applicant requirements are:

1. The applicant must complete the scholarship application in its entirety.
2. The applicant must have their employer forward to the Scholarship Committee a letter on company stationary stating that the employer does not provide tuition reimbursement and that the applicant has been employed a minimum of one year in the commercial real estate industry. If employment has been less than one year, the previous employer may be contacted.
3. The applicant must submit two letters of reference.
4. The Scholarship Committee must receive the application and required letters of recommendations no later than ten days prior to the start of the course. The Committee shall not consider any applicant not meeting all the eligibility and submission requirements. Mail all materials to the Scholarship Committee, c/o BOMA – Greater Hartford, One Regency Drive, Bloomfield, CT 06002.
5. The Scholarship Committee shall inform all applicants in writing of the outcome of the committee selection process. Unsuccessful applicants for the scholarship may be considered in the following semester or any semester thereafter upon submission of a current application, personal essay and letters of recommendation.
